
New charity partners


In 2024, Asthma + Lung UK, Hospice UK and Mind have joined the Trust's portfolio of regularly funded charities, meeting the growing need around additional funding for long term health conditions, including mental health, and end of life care. Three-year Special Award commitments were made to Make-a-Wish UK, Movember and Scope.


Funding in numbers

Over the last 4 years (2021–2024) the Trust has awarded a total of £47.2 million to charities, to support them to improve the health of communities across Great Britain.

In the strategy period, the Trust's funding has supported the following cause areas:







Response to Cost of Living crisis

Throughout this strategy period, we recognize that cost pressures related to the cost of living crisis in the UK affected charities in a number of ways. In response, in 2023 we gave £100,000 of additional unrestricted funding to all of our long-term charity partners, providing them with a much-needed boost in income at the end of a challenging year.



Case Study

On the frontline for families affected by dementia



Flexible funding from the players of People's Postcode Lottery has supported a range of **Alzheimer's Society** services. This support has been a lifeline

for people like Jay Owen, who cared for his grandma, Nanny V. She was diagnosed with vascular dementia the day before his wedding. Prior to that, he had seen the changes in her behaviour. She would become frustrated when she struggled to make a cup of tea or carry a tray, and she would take this frustration out on Jay. She began repeatedly asking questions about what time and day it was. After she was diagnosed, Jay's husband suggested contacting Alzheimer's Society. They went on the website and saw lots of good information, which helped him realise he wasn't alone. He later rang the Support Line:

Jay says: 'I can't thank them enough for their support. If I hadn't spoken to them, I think I would have given up and I didn't want to let Nanny V down.'

Between November 2021 and October 2024, our Support Line has answered more than 160,000 calls, providing advice, guidance and emotional support for people affected by dementia. Players' funding helps to ensure that more people like



Jay and Nanny V can access the support they need when they need it and avoid crisis.

There are over 900,000 people in the UK living with dementia, and many more carers and family members facing the realities of dementia, like Jay, every single day. Flexible funding enables us to provide these services at scale, to support those in greatest need, and ensure that we are there for people as their support needs change.
